AFCOM forays into Australian and Pacific Region countries with the Strategic Relationship of Nauru Air Corporation of Republic of Nauru

- Signs business agreement with Nauru Air Corporation from Republic of Nauru in their High Commission at Delhi on December 05, 2025
- Marks AFCOM's expansion into Trans Continental Pacific cargo corridors

Chennai – December 07, 2025 – AFCOM Holdings Limited (AFCOM), (BSE – 544224), a leading player in the air cargo transportation sector, has executed a major strategic milestone by entering into business relationship with Nauru Air Corporation, the national airline entity of the Republic of Nauru. As part of this evolving relationship, AFCOM and Nauru Air Corporation will explore additional business opportunities, including leasing arrangements and joint commercial initiatives, to strengthen their service offerings across the Pacific and Australian markets.
